The Los Angeles Board of Education acting as the Governing Board of the Los Angeles Unified School District met in regular session on Wednesday, September 17, 2025, at the Administrative Offices, Board Room, 333 South Beaudry Avenue, Los Angeles, California.

The Board recessed the public portion of the closed session meeting at 10:51 a.m. Closed session discussion began at 11:00 a.m. and ended at 3:58 p.m. The following Board Members were present: Ms. Newbill, Dr. Rivas, Mr. Melvoin, Ms. Griego, Ms. Gonez, and Ms. Ortiz Franklin and Board President Schmerelson.

The Board reconvened the public portion of the closed session meeting at 4:04 p.m.

The following Board Members were present: Ms. Newbill, Dr. Rivas, Mr. Melvoin, Ms. Griego, and Board President Schmerelson.

Ms. Gonez and Ms. Ortiz Franklin were absent.

Mr. McLean announced the following reportable actions resulting from the closed session discussion:

- The Board of Education approved the expulsion of students in case numbers, 005-25/26, 007-25/26, 008-25/26, 009-25/26, and 010-25/26, with the recommended dispositions. The Board of Education denied the enrollment of the students in case numbers 001A-25/26, 002A-25/26, and 004A-24/25, with the recommended dispositions. The vote in all matters was 7 ayes.
- The Board of Education approved the conditional enrollment of the student in case number 005A-25/26, with the recommended disposition. The vote was 6 ayes, 1 no (Mr. Schmerelson).
- The Board of Education approved the conditional enrollment of the student in case number 003A-25/26, with the recommended disposition. The vote was 7 ayes.
- The Board of Education authorized the settlement in the case of Bautista, Kathrina v. Los Angeles Unified School District. The vote was 6 ayes, 1 absent (Ms. Gonez).
- The Board of Education authorized the settlement in the case of Milton, James Oree v. Los Angeles Unified School District. The vote was 7 ayes.
- The Board of Education authorized the settlement in the case of Jane Doe, Jane Roe v. Los Angeles Unified School District, et al. The vote was 6 ayes, 1 absent (Ms. Gonez).
- The Board of Education authorized the dismissal of 2 certificated employees. The vote was 7 ayes.
- The Board of Education reappointed Alberto Carvalho as Superintendent of Schools for four years, with the term ending February 13, 2030. Terms and conditions will be disclosed upon finalization and prior to ratification of the contract and open session on October 14, 2025. The vote was 7 ayes.
