CA School Dashboard: English Learner Progress Indicator (ELPI)

The English Learner Progress Indicator (ELPI) relies on the results of the Summative English Language Proficiency Assessment (ELPAC), including Summative Alternate ELPAC results, to determine EL student progress. ELPI Change measures the rate at which schools are improving their ability to move their EL students towards English language proficiency.
