CA School Dashboard: English Learner Progress Indicator (ELPI)

ELPI Change measures the rate at which schools are improving their ability to move their EL students towards English language proficiency. Low Incidence Students are defined as those in the Autism, Deafness, Emotional Disturbance, Hard of Hearing, Intellectual Disability, Multiple Disabilities, Orthopedic Impairment, Traumatic Brain Injury, and Visual Impairment categories.
